Note: **Drop-In** as needed \$8.00 per hour no prorated hours. Billing for Drop-In daycare will be posted to your account by the 5th of the following month.

DAYCARE PLAN B & C rates include fees for RHLS After School Enrichment Classes ONLY on a first come first served basis (Outside vendor classes require additional fees). Conference Day Camp, Thanksgiving Camp and/or Easter Camp will be billed separately.

Registration and payment for Daycare Plans will take place at the beginning of the school year, during Meet the Teacher Day.

- Two payment options are available for Plan A, B, or C.
 - **ONE** Payment option: The full amount is due September 1, 2016.
 - **NINE** Payment option: Daycare is paid monthly, over a 9 month period, which begins September 1, 2016 and ends May 1, 2017.
- My child will be picked up by 6:00 PM. I understand that I will be billed a late charge of \$15.00 per every 15 minutes, per child after 6:00 PM with no cap.
- I further understand that if there is a behavior/discipline problem with my child in daycare, that I will be notified. If behavior/discipline continues to be a problem, he/she may be removed from daycare at the discretion of the Preschool Director.
- Parent/Guardian whose signature is executed on this agreement is personally and fully responsible for the payment of all daycare charges incurred. In the event of a separation or legal marriage status change, signatory is fully responsible for full payment. RHLS will assume no responsibility for collection of account from any other party who is not signatory on this agreement.
- I understand Daycare Plan B & C rates include course fees for RHLS After School Enrichment Classes ONLY, on a first come, first served basis, (outside vendor classes require additional fees), supply fees are not included. Conferences Day Camp, Thanksgiving or Easter Camps will be billed separately. There will be no Christmas Camp this year.
- I understand that to terminate enrollment in the Daycare Plan I must notify the school office in writing 30 days prior to withdrawal. There will be no refunds after April 1, 2017. There are no partial month refunds for midyear withdrawal.
- I understand that once withdrawn from the Daycare Plan, I am ineligible to re-enroll my student in a Plan until the following school year (2017-2018). All remaining 2016-2017 daycare fees will be charged at the drop-in rate of \$8.00 per hour.
